INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

Supply and Delivery of Desktop Computers for the Bureau of Communications Services (BCS-BAC NP-2020-001)

1. The **BUREAU OF COMMUNICATIONS SERVICES**, through the **2020 National Expenditure Program** intends to apply the sum of **Two Million and Thirty-Five Thousand Pesos Only (Php 2,035,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Desktop Computers for the Bureau of Communications Services**.
2. The BCS, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the mentioned goods and services.
3. The procurement procedure for this procurement is Negotiated Procurement due to two (2) failed biddings pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act", including Annex "H" thereof.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

The BAC will engage in negotiations with a sufficient number of suppliers to ensure effective competition. **The selection of the successful offer shall be based on the best and final offer that will be submitted on a specified date, which could meet the technical specifications.**

4. Interested bidders may obtain further information from **BCS-BAC Secretariat** and inspect the Bidding Documents at the address given below during 8:00 a.m to 5:00 p.m Monday to Friday.


