Early Procurement Activities

I hereby certify that the **BUREAU OF COMMUNICATIONS SERVICES** has conducted **Early Procurement Activities for at least Fifty Percent (50%) for the supply and delivery of desktop computers for the Bureau with an ABC of PhP2,035,000.00, however, the bidding thereon twice (2) failed** under the following circumstances:

1. On 19 December 2019, the pre-bid conference for supply and delivery of desktop computers for the Bureau was held where only one (1) prospective bidder attended, **Mr. Jerome F. Rosario of Machine Mart, Inc.** Copy of the **Minutes** dated December 19, 2019 is herein attached as **Annex "A"**;
2. On 06 January 2020, the opening of bids was not undertaken and declared as failed in view of the fact that no prospective bidder arrived, as per **Minutes** dated January 6, 2020 herein attached as **Annex "B"**;
3. On 16 January 2020, a pre-bid conference was once again undertaken where BCS BAC Chairperson Esther V. Gyenes-Guibone fielded clarificatory questions to the prospective bidders, as contained in the **Minutes** dated January 16, 2020 herein attached as **Annex "C"**;
4. Come 24 January 2020, an opening of bids for the said supply and delivery was undertaken by the Committee, however, no prospective bidder arrived/participated thereto, thus, the same was once again considered as failed, as a matter of course. A copy of the **Minutes** dated January 24, 2020 is herein attached as **Annex "D"**;
5. The BCS-BAC undertakes to comply with the early procurement activities notwithstanding the said failure of the bidding on the aforementioned delivery and supply of desktop computers.

This Certification is issued in compliance with the procurement law and pertinent directives of the Government Procurement Policy Board.
