



## BCS BIDS & AWARDS COMMITTEE (BCS-BAC) RESOLUTION NO. 2020-11-0001

### DECLARING A FAILURE OF BIDDING FOR “SUPPLY AND DELIVERY OF NOTEBOOK AND PEN SET FOR USE IN THE PHILIPPINE IDENTIFICATION SYSTEM PROJECT BY THE BUREAU OF COMMUNICATIONS SERVICES”.

**WHEREAS**, The Special Operation Division (SOD) submitted the Terms of Reference (TOR) and Purchase Request for the “Supply and Delivery of Notebook and Pen Set for use in the Philippine Identification System Project by the Bureau of Communications Services” with Approved Budget for the Contract (ABC) Php 1,994,300.00 (**Annex A**);

**WHEREAS**, After posting/publishing Invitation to Bid (ITB) on both the BCS Bulletin Board and the Philippine Government Electronic Procurement System (PhilGEPS) Website on 04 November 2020 (**Annex B**), one prospective bidder submitted bids for this procurement activity, namely; Bigvision International Trade & Industries Corp. was posted on the Philippine Government Electronic Procurement System website, the BCS website and all BCS Bid bulletin boards;

**WHEREAS**, during the opening of Bid on 24 November 2020, the prospective bidder submitted the technical and legal components of bid, respectively. The BCS-BAC evaluated the bid using the non-discretionary “pass/fai” criterion;

**WHEREAS**, The BAC’s evaluation revealed the following :

Bidder	Evaluation
Bigvision International Trade & Industries Corp	Upon opening of bid wrong documents attached which intended for the “Supply and Delivery of Reusable Facemask for use in the Philippine Identification System Project by the Bureau of Communications Services” and not for Supply and Delivery of Notebook and Pen Set.

**WHEREAS**, consequently, the bidder was declared ineligible (**Annex C**)

**WHEREAS**, Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIIR) of R.A No. 9184 provides in pertinent part:

#### “Section 35. Failure of Bidding

##### 35.1 The BAC shall declare the bidding a failure when:

**b.) All prospective bidders are declared ineligible;  
xxx”**

**WHEREAS**, pursuant to Section 35.2 of the IRR of R.A No. 9184, in order to determine the reason for the failed procurement activity, the BCS-BAC, shall conduct a mandatory review and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents;

**NOW, THEREFORE**, for & in consideration of the foregoing, **WE**, the members of the BCS-BAC, hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR “SUPPLY AND DELIVERY OF NOTEBOOK AND PEN SET FOR USE IN THE PHILIPPINE IDENTIFICATION SYSTEM PROJECT BY THE BUREAU OF COMMUNICATIONS SERVICES.**


