DECLARATION FOR 1st FAILURE OF BIDDING FOR THE “SUPPLY AND DELIVERY OF ONE (1) UNIT OF HIGHSPEED MULTIFUNCTIONAL DIGITAL PRINTER”

WHEREAS, The Special Production Division (SPD) submitted the Terms of Reference (TOR) and Purchase Request for the “Supply and Delivery of One (1) Unit of Highspeed Multifunctional Inkjet Digital Printer” with Approved Budget for the Contract (ABC) Php 600,000.00 (Annex A).;

WHEREAS, On 11 April 2022 posted/published Invitation to Bid (ITB) on both BCS Bulletin Board, BCS Website and Philippine Government Electronic Procurement System (PhilGEPS) (Annex B);

WHEREAS, On 19 April 2022 the BAC conducted a Pre-Bid Conference and explained/clarified the details of the technical and procurement aspects of the solicitation documents to the interested bidders;

WHEREAS, On May 02, 2022, the BAC conducted the Opening of Bid for the said contract and as per result of the evaluation of the Eligibility and Technical Documents and the Documents Comprising the Bid: Financial Component, three bidders were found eligible to participate in public bidding, namely: **ISOURCE ASIA BUSINESS SOLUTIONS CORPORATION, SONKKENS OFFICE EQUIPMENT TRADING and PANTRONICS INTERNATIONAL CORPORATION**, upon the BAC’s detailed evaluation of all bids using non-discretionary criteria in considering the completeness of the bid and arithmetical corrections;


WHEREAS, upon Post Qualifications of three bidders the BAC declared **ISOURCE ASIA BUSINESS SOLUTIONS CORPORATION, SONKKENS OFFICE EQUIPMENT TRADING and PANTRONICS INTERNATIONAL CORPORATION** post-disqualified. Attached herewith the resolution declaring post-disqualification of three bidders as (Annex C).


WHEREAS, Section 35.1 (b) of the Revised IRR of R.A 9184 provides, “The BAC shall declare failure of bidding when:


c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;
