PUBLIC BIDDING NO. 2022-08-0008

1. The **BUREAU OF COMMUNICATIONS SERVICES**, through the **General Appropriation Act for Fiscal Year 2022** intends to apply the sum of **Two Million and Ten Thousand Pesos Only (Php 2,010,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Two (2) Units of LED Wall**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **BUREAU OF COMMUNICATIONS SERVICES** now invites bids for **Supply and Delivery of Two (2) Units of LED Wall**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from **BCS-BAC Secretariat** and inspect the Bidding Documents at the address given below Monday to Friday (except non-working days), 8:00A.M. to 4:00P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 04 to August 24, 2022, from 8:00 A.M. to 4:00 P.M.** from the address below and upon payment of the nonrefundable fee for the Bidding Documents in the amount of **Php 5000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **August 24, 2022, 01:00 P.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**

Bid opening shall be on **August 25, 2022, 1:00 P.M.** at **Office of the Director Meeting Room, 2nd Floor** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


